

## NMPCA Board Terms and Officers: 2022 (approved by Board, August 2022)

- Rules:** -6-14 board members. Board members are elected by members at the annual meeting.  
 -Board member term: 3 years, 2 consecutive terms, must be off-board one year before reelected.  
 -Officer term: 1 year, consecutive terms can be served. Elected by the board, not members.  
 -Terms are served from Annual Meeting to Annual Meeting (currently Feb to Feb).  
 -Quorum – one-half the total number of board members.
